- Introduction of new employment models within the private acute market.

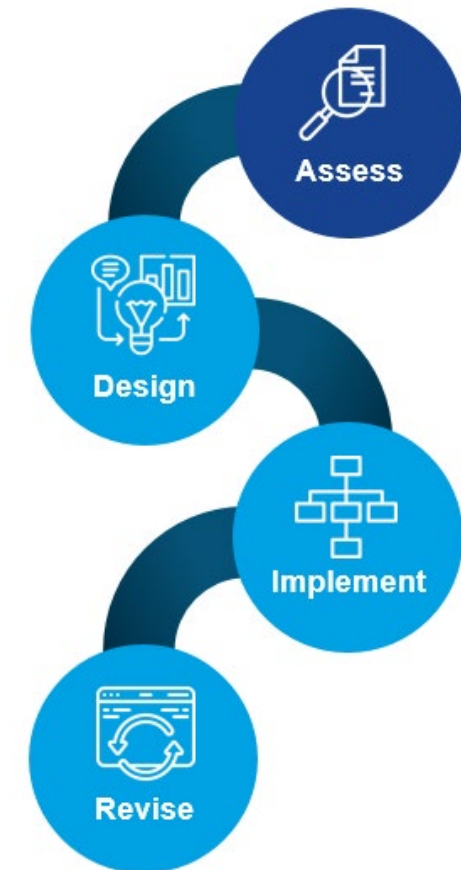
